# ITSE 1311 - Beginning Web Programming: Fall 2016 Syllabus for Section 6001/2

Credit Hours: 3

## **Course Description**

This course is designed to equip you, the student, with the fundamental programming skills necessary to build HTML-based web pages. Generally (and per the course catalog), this course will develop skills used in web programming including mark-up and scripting languages.

## **Incompletes**

The instructor must submit a signed "I" contract to the appropriate division; students will receive a copy of the contract following approval by the Dean or designee.

## **Early Alert**
